### HARLEM GLOBETROTTERS WIN FLOOR TICKETS CONTEST-OTTAWA SUN

### **CONTEST RULES**

### **ELIGIBILITY**

- 1. The Harlem Globetrotters Contest Ottawa Sun (the "Contest") is conducted by Capital Sports Properties Inc. (the "Sponsor") and is open to all legal residents of Canada (excluding residents of the province of Quebec) who have reached the age of majority in the province in which they reside.
- 2. Entrants are not eligible to participate in the Contest if they are:
  - a) employees, agents or representatives of the Sponsor, or its agents, affiliates, subsidiaries, related companies, sponsors, advertising or promotional agencies, or assignees; or
  - b) a member of the household and/or immediate family of any of the above parties. For the purpose of the Contest Rules, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether or not they reside in the same household.
- 3. The Sponsor shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof within a reasonable period of time may result in disqualification. All personal and other information requested by and supplied to the Sponsor for the purpose of this Contest must be truthful, complete, accurate and in no way misleading. The Sponsor reserves the right to disqualify any entry or entrant in its sole discretion, should any entry or entrant at any stage contain and/or supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

### **HOW TO ENTER**

- 4. The Contest begins on Thursday, March 23, 2017 at 9 am and ends on Monday, April 3, 2017 at 5 pm (the "Contest Period"). All times listed in the Contest Rules refer to Eastern Standard Time.
- 5. There is no purchase necessary to enter the Contest. To enter either:
  - a) complete the entry form located in the Ottawa Sun insertion dates **Thursday, March 23, Sunday, March 26** and **Tuesday, March 28, 2017** or
  - b) create a hand-drawn ballot marked **Harlem Globetrotters Ottawa Sun Contest**" indicating the following information: your full name, address, home telephone number, and valid email address, and mail/drop off the ballot to the attention of the Sponsor located at Canadian Tire Centre, 1000 Palladium Drive, Kanata, Ontario, K2V 1A5 or
  - c) Visit <u>www.canadiantirecentre.com/contests</u> to enter on line. No entries will be accepted by any other means
- 6. Entries are limited to one (1) entry per person per day. In the case of multiple entries, only the first entry will be considered. All entries become the sole property of the Sponsor and none will be returned for any reason. All entries must be received during the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, falsified, altered, garbled, mechanically or electronically reproduced, or tampered with in any way.

Entries received online shall be deemed to be submitted by the authorized account holder of the e-mail address associated with the Entry. For the purpose of the Contest Rules, "authorized account holder" of an e-mail address means the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Potential winner may be required to provide Sponsor with proof that the potential winner is the authorized account holder of the e-mail address associated with the winning Entry.

## **PRIZE**

7. (a) There will be one (1) Grand Prize ("The Grand Prize") awarded to the Grand Prize winner consisting of four (4) tickets in the Floor section to see the Harlem Globetrotters at Canadian Tire Centre on Friday, April 7, 2017 at 7 p.m. The prize also include four (4) Magic Passes to the pre-event interaction session

- which is prior to the show. The approximate retail value of the Prize is Cdn \$416, not including taxes and applicable fees. The odds of winning depend upon the number of eligible entries received
- (b) There will be one (1) Secondary Prize (the "Secondary Prizes") awarded to the Secondary Prize winners (the "Secondary Prize Winner") in accordance with section 10 below each consisting of four (4) tickets in the 100-level to see the Harlem Globetrotters at Canadian Tire Centre on Friday, April 7, 2017 at 7 p.m. The approximate retail value of each Secondary Prize is Cdn \$88.00 excluding taxes and applicable fees.
- (c) The Grand Prize and the Secondary Prizes may be generally referred to herein as a "Prize" and collectively referred to herein as the "Prizes". The Grand Prize Winner and the Secondary Prize Winners may be generally referred to herein as a "Winner" and collectively referred to herein as the "Winners". The odds of winning a Prize depend upon the number of eligible entries received. ### **RANDOM DRAW**

On Tuesday, April 4, 2017 at 9 a.m. at Canadian Tire Centre in Kanata, Ontario, two (2) eligible entrants will be selected by a random draw from all eligible entries received to receive a Prize. The first eligible entrant selected, subject to compliance with the Contest Rules, shall receive the Grand Prize. The second eligible entrant selected, subject to compliance with the Contest Rules, shall receive a Secondary Prize. Selected eligible entrants will be notified by phone, or email on or before Tuesday, April 4, 2017 at 5 p.m. If a selected eligible entrant cannot be contacted by phone, or email on or before Wednesday, April 5, 2017 at 11 a.m., he/she will be disqualified and another eligible entrant will be selected and contacted. The Sponsor is not responsible for a selected eligible entrant's failure to receive notification for any reason whatsoever.

## **SKILL TESTING QUESTION**

11. In order to be eligible to win the Prize, the selected eligible entrant shall be required to correctly answer a time-limited, mathematical skill-testing question, without assistance of any kind, whether mechanical, electronic or otherwise. ### PUBLICITY RELEASE AND RELEASE OF LIABILITY

The Sponsor is not responsible or liable for late, lost, incomplete, illegible, misdirected, stolen, delayed, damaged or destroyed entries, notifications, replies or any Contest Release; for lost, interrupted, inaccessible or unavailable networks, servers, Internet Service Providers, websites or other connection, related to the Contest and/or the Contest Website; for errors of any kind, including but not limited to human, electronic, mechanical and/or technical in nature; for failure or technical malfunction of any telephone network or lines, computer and online systems, servers, computer equipment, software, e-mail, players, or browsers on account of technical problems or traffic congestion on the Internet, the Contest Website, any related website, or any combination thereof or otherwise; for any injury or damage to entrant, entrant's computer, or any other person's computer related to or resulting from participating in or downloading material in connection with the Contest; for incorrect or inaccurate information; and/or for weather conditions, event cancellations, delay or rescheduling or other factors beyond the Sponsor's control.

The Sponsor reserves the right, in its sole discretion, to disqualify any entrant who is found to be tampering with the entry process or with the operation and administration of the Contest; acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Contest; or in violation of the Contest Rules. The Sponsor reserves the right to seek damages and other remedies from any such entrant to the fullest extent permitted by law, including but not limited to criminal prosecution.

### **USE OF PERSONAL INFORMATION**

16. By participating in the Contest, the entrant consents to the collection, use and disclosure of his/her personal information by the Sponsor for the purpose of administering the Contest, awarding the Prize and announcing the Winner and any subsequent advertising or promotion related thereto. Personal information collected in connection with the Contest will be used by the Sponsor in accordance with the Sponsor's privacy policy available at www.canadiantirecentre.com.

17. All intellectual property, including but not limited to trade-marks, trade names, logos, designs, promotional materials, web pages, source code, drawings, illustrations, logos, slogans and representations are owned or used under licence by the Sponsor and/or its affiliates. All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.

## **GOVERNING LAW**

- 18. The Contest is subject to applicable federal, provincial and municipal laws and regulations and is void where prohibited by law. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsor in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
- 19. The Sponsor reserves the right, in its sole discretion, to terminate the Contest, in whole or in part, or modify, amend or suspend the Contest and/or the Contest Rules in any way

at any time for any reason without prior notice or compensation.

## **DISCREPANCIES**

20. In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules and disclosures or other statements contained in any Contest-related materials or advertising, the terms and conditions of the Contest Rules shall prevail, govern and control.
